- 3) Provide the certified copy of the summon issued to me and my family.
- 4) Provide the *certified copy of investigation report*.
- 5) Provide the certified copy of report by the police officer.
- 6) Provide the certified copy of the report of protection officer which has been shared with the police station of the jurisdiction of the incident.
- 7) Provide the certified copy of the medical report, which was examined during the investigation by the Protection officer.
- 8) Provide the certified copy of the Domestic incident report.
- 9) Provide the certified copy of the evidence submitted by my wife to the protection officer during the inquiry/investigation.
- 10) Provide the certified copy of the statement, affidavit and complaint by my wife to the protection officer during the inquiry/investigation.

- 11) Provide the date and Time of the protection officer left the office to the place of incident
- 12) Provide the mode of travel Private/Public/Office used by the protection officer to the place of incident.
- 13) Provide the start and end mile meter reading of the vehicle, used by the protection officer to the place of incident.
- 14) Provide the List of all the officers with their name, name of agency and designation, accompanied the Protection Officer to the place of incident.
- 15) Provide the date and time of the protection officer reached to the place of incident.
- 16) Provide the number witnesses interrogated and registered their statements at the place of incident.
- 17) Provide the certified copy of observation of the Protection Officer and the other agencies accompanied to the place of incident.
- 18) Provide the date and time of the protection officer left the place of incident.
- 19) Provide the date and time of the protection officer reached back to the office.

Please provide the reason in case any of the information could not be provided to me.

Please provide the first appellate correspondence details.
